**Approved Action/Determination:** Shoreline Exemption determination for proposed replacement of a boat lift on an existing pier. The proposal is determined to be exempt from a Shoreline Substantial Development Permit per the city's adopted Shoreline Master Program (SMP), Section 3.3.C.6(b).

**Environmental Review:** After review of the proposal, application, supporting materials, and the State Environmental Policy Act (SEPA), the City has determined that the proposal is categorically exempt from environmental review under WAC 197-11-800(3).

**Conditions:** This determination is based on findings and conclusions that the project design minimizes impacts to shoreline habitat with the following conditions of approval:

1. Installation shall comply with all regulations as stipulated by State and Federal agencies, local Tribes, or others that have jurisdiction, including the Army Corps of Engineers and Washington Department of Fish and Wildlife.
2. Platforms shall be fully grated.
3. Structure that is in direct contact with water or over water shall not be treated or coated with herbicides, fungicides, paint, or pentachlorophenol.

**Appeals:** Pursuant to Section 3.6 of the city's adopted Shoreline Master Program, this Type-III decision may be appealed by the applicant, private or public organization, or individual to the

City of Lake Forest Park Hearing Examiner within ten (10) calendar days following the written decision and publication of this Notice of Decision. To do so, prior to the close of business (5pm) on May 23, 2025, submit a written appeal statement to City Clerk, Matthew McClean, at mmcclean@cityoflfp.gov or 17425 Ballinger Way NE, Lake Forest Park, WA 98155, along with a required \$500 filing fee. You should be prepared to make specific factual objections in your written appeal.
