DETERMINATION OF NONSIGNIFICANCE (DNS)  
WAC 197-11-340**

**Project:** City of Lake Forest Park 2025 Comprehensive Plan Amendment for a new Climate Element with resilience and greenhouse gas reduction sub elements.

**Description of proposal:** The subject proposal is the 2025 amendment for a new Climate Element to the City's Comprehensive Plan, as required by the WA State Growth Management Act (GMA). The Comprehensive Plan addresses the city's 20-year population and employment growth targets and provides policy guidance for the city's growth and development through 2044. The GMA now requires the city to update its comprehensive plan prior to 2029 for climate goals and policies as per WA State House Bill 1181 enacted in 2023.

**Proponent:** City of Lake Forest Park, 17425 Ballinger Way NE, Lake Forest Park, WA 98155.

**Location of proposal, including street address, if any:** Citywide (Non-project SEPA Action).

**Lead Agency:** City of Lake Forest Park, 17425 Ballinger Way NE, Lake Forest Park, WA 98155.

**Determination:** The City of Lake Forest Park, as lead agency for this proposal, after reviewing a completed environmental checklist and other information on file for the non-project action, has determined that the proposed amendments to the Comprehensive Plan do not have a probable adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). Information on file for this proposed project is available to the public on request to the lead agency. The proposal is a non-project action per WAC 197-11-774; however, all project-level improvements will be subject to individual environmental review at the time of their future application.

This Determination of Non-Significance (DNS) is issued Monday, October 20, 2025, under WAC 197-11-340 and the City of Lake Forest Park Municipal Code (LFPMC). A 14-day comment period will commence from the date of distribution/publishing (Wednesday, October 22, 2025) of the DNS. presentation and separately noticed public hearing for the climate amendments will be held at the City Council on November 13, 2025.
